3.	<input type="checkbox"/>	MUST submit ALL <b><u>PASSPORTS</u></b> that you hold (including current/ old/ cancelled/ expired/ special)
4.	<input type="checkbox"/>	<p>Must enclose the following documents:</p> <p><b>1. Visiting Relative:</b></p> <p style="margin-left: 20px;">a) If invited by a friend / relative in Israel attach invitation letter with contact details of the invitee (Place of residence in Israel, full address and phone number)</p> <p style="margin-left: 20px;">b) Approval Letter from the place of work for your travel. If you are an employee in a company, please provide a valid official letter from your employer in English with position in company</p> <p style="margin-left: 20px;">c) Last three months of bank statement, in which the name of the applicant appears clearly. With original bank stamp if the applicant has a business account, please also attach a copy of that account (for last 3 months)</p> <p style="margin-left: 20px;">d) For students, Student ID is required.</p> <p style="margin-left: 20px;">e) Family book.</p> <p><b>2. Tourist Visit :</b></p> <p style="margin-left: 20px;">a) A hotel reservation in Israel, including the hotel's name, the city, phone number and number of reservation.</p> <p style="margin-left: 20px;">b) Last three months of bank statement, in which the name of the applicant appears clearly. With original bank stamp.</p> <p style="margin-left: 20px;">c) If you are an employee in a company please provide a valid official letter from your employer in English, stating your position in the company / for students, ID student is required.</p> <p><b>3. <u>Visa for a Medical Treatment:</u></b></p> <p style="margin-left: 20px;">1) A formal invitation from the hospital with the treatment's dates.</p> <p style="margin-left: 20px;">2) Reports from a Jordanian doctor.</p> <p style="margin-left: 20px;">3) Place of residence in Israel (full address and phone number).</p> <p style="margin-left: 20px;">4) Last three months of bank statement, in which the name of the applicant appears. With original bank stamp</p>

## **IMPORTANT REMARKS**

1. Attach one set of photocopy of all the documents as mentioned above (Only A4 size and not in back to back format)
2. IN CASE OF MINOR ACCOMPANYING PARENTS: - **MINOR PROCESS**
  - a) Parents (Father/Mother) need to present at the embassy for signing the Minor consent form (schedule appointment for the visit in the embassy through (RSELG))
  - b) In case one of the parent is not in country then he/ she must sign the Minor consent form at Embassy of Israel in that particular country.
3. Embassy may ask for additional documents or request for personal appearance at the Embassy.
